4 IF YOU FAIL TO ANSWER THIS WRIT OR TO WITHHOLD PROPERTY IN  
5 ACCORDANCE WITH THE WRIT, THE COURT MAY MAKE YOU LIABLE FOR  
6 THAT AMOUNT OF THE DEBTOR'S NON-EXEMPT PROPERTY WHICH YOU FAIL  
7 TO WITHHOLD. ADDITIONALLY, YOU MAY BE HELD LIABLE FOR A  
8 REASONABLE ATTORNEY'S FEE TO THE UNITED STATES OF AMERICA IF THE  
9 UNITED STATES FILES A PETITION TO THE COURT REQUESTING AN  
10 EXPLANATION FOR YOUR FAILURE TO COMPLY WITH THIS WRIT.
