 23 evidentiary hearing on Defendants' motion to terminate, scheduled to begin May 10, 2010.

2 2005).

3 2. Mendez was released on parole in January, 2010.


4 3. On March 29, 2010, Mendez was charged and convicted of the felony offense of grand


