In view of the parties' stipulation, and good cause appearing thereof, the California Department of Education and the Ravenswood City School District shall pay plaintiffs' attorneys' fees and costs in this action for the period of January 1, 2009 through December 31, 2009. Attorneys' fees and costs in the amount of \$ 13,618.37.00 will be paid to the Disability Rights Education and Defense Fund, Inc.; and attorneys' fees in the amount of \$ 27,580.00 will be paid to the Youth and Education Law Project.


The payments shall be equally divided between the California State Department of Education and the Ravenswood City School District.
