23 Counsel for the defendants have prepared a stipulated order setting a briefing schedule
 24 regarding attorneys' fees and costs in this action for the period of January 1, 2015 through June
 25 30, 2015.

26 Pursuant to Section 17.0 of the First Amended Consent Decree, if the defendants are
 27 unable to agree on the allocation of the responsibility for plaintiffs' attorneys' fees in this case,
 28

1 the defendants may seek Court intervention. At this time, the defendants have reached an
2 impasse regarding the allocation of responsibility for payment of plaintiffs' attorneys' fees and
3 costs, and therefore, respectfully request that the defendants be permitted to brief the issue before
4 this Court.

5 To this end, the parties propose the following briefing schedule. As primary counsel for
6 the District will be unavailable February 12 through 22, 2016, it is respectfully requested that any
7 hearing date be set for a date after February 22, 2016, to accommodate that unavailability.

8 1. Defendants shall by no later than January 28, 2016, file separate opening briefs
9 setting forth their respective positions with respect to the allocation of plaintiffs' attorneys' fees
10 and costs for the period of January 1, 2015 through June 30, 2015.

11 2. Defendants shall respond to each other's opening briefs by no later than February
12 11, 2016. If Plaintiffs wish to address this matter, they may file comments responding to
13 Defendants' opening briefs no later than February 11, 2016. The Court shall hold a hearing on
14 the attorneys' fees and costs issue on _____.
