14 This written order confirms the following oral rulings made by the Court during the
15 September 3, 2009 status conference:

16 1. Defendants shall pay Plaintiffs' counsel reasonable attorneys' fees for work
17 performed under the contemplated memorandum of understanding ("MOU"). The parties
18 shall meet and confer on the process for payment of such fees.

19 2. A stipulation and proposed order adopting the MOU shall be presented to this
20 Court on or before **September 30, 2009**. If full agreement has not been reached by that date,
21 the parties shall file a joint statement setting forth their respective proposals for further
22 proceedings, including a proposed briefing schedule if no agreement has been reached or a
23 timeline for obtaining prompt approval from the City Council if an agreement has been
24 reached but Council approval has not yet been attained.


25 3. The process to select the independent monitor(s) during the MOU period shall be
26 completed by the date of the next status conference. If the selection process has not yet been
27 completed, then the parties shall explain in their joint status conference statement the reasons
28 for any delay and the anticipated schedule for completion.
