

6 on regularly for hearing before this Court on March 20, 2009. Michael A. McGill
7 did not appear for plaintiffs in the Weaver and Moynihan cases; David P. Clisham
8 appeared for plaintiffs in the Green case; Margaret Baumgartner, Deputy City
9 Attorney, appeared for Defendant City and County of San Francisco.

10 The Court, having reviewed and considered Plaintiffs' Motion for Order
11 Approving Settlement of FLSA Claims, the Declarations of Michael A. McGill
12 and Robert A. Jones, Plaintiffs' Memorandum of Points and Authorities in
13 Support of Motion for Settlement of FLSA Claims and Defendant City and
14 County of San Francisco's Response and Supplement Response To Motion for






