17	3. On April 13, 2008, the Federal Defendants filed the United States' Answer to
18	Plaintiff's Second Amended Complaint and Counterclaim (D.I. 111).
19	3. On January 16, 2009, Plaintiff filed its Third Amended Complaint that removed its
20	previously pled Seventh to Tenth Causes of Action.

22	The Parties hereby agree that the answers filed by the TRC Parties, the Generator
23	Defendants (including the Prewetts), and the Federal Defendants to Plaintiff's Second Amended
24	Complaint will serve as their answers to Plaintiff's Third Amended Complaint.
