**JOINT STIPULATION AND [PROPOSED
 ORDER] REQUESTING TO CONTINUE
 CASE MANAGEMENT CONFERENCE
 TO MAY 20, 2011**

20 On November 5, 2008, the Court ordered “[t]hat the case shall be continued pending
 21 appeal of the underlying criminal case,” *United States v. Prabhat K. Goyal*, 3:04-cr-0201-SI,
 22 Ninth Circuit Case No. 08-10436, and continued the initial case management conference at the
 23 request of both parties because the appeal had not been concluded. [Dkt. No. 36.]

24 On December 10, 2010, the Ninth Circuit issued an Order reversing the jury verdict and
 25 remanding for entry of judgment of acquittal on all counts. On February 11, 2011, the Court
 26 continued the case management conference, which was then set for February 18, 2011, to March
 27 18, 2011 to allow the parties to attempt to reach a resolution of the matter. [Dkt. No. 62.]

28 The parties remain in the process of attempting to reach a resolution of this matter.
 Accordingly, they respectfully request the Court to continue the stay, and to enter the
 accompanying proposed order continuing the case management conference currently scheduled
 for March 18, 2011 to May 20, 2011.

2 appearing therefore,


3 IT IS HEREBY ORDERED that:
