The Commission's Fourth Claim for Relief in the Complaint, to the extent that it 17 asserts a claim under Rule 13b2-2 promulgated under the Securities Exchange Act of 1934 18 (Making False Statements to Auditors), is dismissed with prejudice upon the Court's entry of the 19 Final Judgment. 20 3.
