This amount represents compensation for all legal 23 services rendered on behalf of Plaintiff by counsel in connection with this civil action, in accordance 24 with 28 U.S.C. § 2412(d). 25 This stipulation constitutes a compromise settlement of Plaintiff's request for EAJA attorney 26 fees, and does not constitute an admission of liability on the part of Defendant under the EAJA. 27 Payment of NINE THOUSAND dollars and 00 cents (\$9,000.00) in EAJA attorney fees, shall constitute 28 a complete release from and bar to any and all claims Plaintiff may have relating to EAJA fees in

connection with this action.
