Plaintiffs CLRB Hanson Industries, LLC d/b/a Industrial Printing and Howard Stern, on behalf of themselves and all other similarly situated, were permitted to submit a supplemental brief in further support of their Motion for Partial Summary Judgment. On May 7, 2007, Plaintiffs filed Plaintiffs' Supplemental Memorandum in Support of Plaintiffs' Motion for Partial Summary Judgment ("Plaintiffs' Supplemental Memorandum") and the Supplemental Declaration of Michele F. Raphael dated May 3, 2007 ("Supplemental Raphael Declaration").

On May 7, 2007, Plaintiffs moved pursuant to Civ. L.R.79-5 to have those portions of Plaintiffs' Supplemental Memorandum and the Supplemental Raphael Declaration, which Plaintiffs represent reference, incorporate or otherwise cite material designated as "Confidential" by Defendant Google, Inc., pursuant to the stipulated protective order, filed on March 2, 2007 and entered on May 15, 2007.

By letter dated May 14, 2007, Defendant advised Plaintiffs of its limited objections to Plaintiffs' redactions. Also, on May 14, 2007, Defendant reiterated its objections in the Declaration of M. Christopher Jhang in Response to Plaintiffs. Administrative Motion Pursuant to Civ. L.R. 79-5 (D) to File Under Seal Portions of Documents also dated May 14, 2007.

On May 21, 2007, Plaintiffs lodged with this Court highlighted versions of Plaintiffs' Amended Supplemental Memorandum in Support of Plaintiffs' Motion for Partial Summary Judgment and the Amended Supplemental Declaration of Michele F. Raphael (dated May 3, 2007), identifying the portions containing, citing or referring to material designated by Google as confidential and reflecting Defendant's comments of May 14, 2007. Plaintiffs have also lodged with the Clerk a redacted version of Plaintiffs' Amended Supplemental Memorandum in Support of Plaintiffs' Motion for Partial Summary Judgment and the Amended Supplemental Raphael Declaration of Michele F. Raphael dated May 3, 2007.
