**STIPULATION AND [PROPOSED]
 ORDER DISMISSING PLAINTIFF
 ADELINE CHAN’S CLAIMS AND SUCH
 PART OF THE CLASS THAT SHE
 REPRESENTS**

1 **STIPULATION**

2 Pursuant to the Northern District of California Local Rules 77-2(c) and Federal Rules of Civil
3 Procedure 41, Plaintiff Adeline Chan (“Plaintiffs”) and Defendants Contra Costa County, Contra Costa
4 County Sheriff’s Department, and Contra Costa County Sheriff Warren Rupf (“Defendants”), hereby
5 stipulate as follows:

6 WHEREAS, the parties stipulate that the claims of Plaintiff Adeline Chan shall be dismissed with
7 prejudice pursuant to the Ninth Circuit’s *en banc* decision in *Bull v. City and County of San Francisco*,
8 565 F.3d 964, issued on February 9, 2010; and

9 WHEREAS, the claims of all class members who were subject to only one strip search, prior to
10 housing, without reasonable suspicion, shall also be dismissed;

11 WHEREAS female class members subjected to a *second* strip search before being housed under
12 Defendants’ uniform policies, shall remain as class members, the liability for which Defendants dispute
13 as a matter of law and fact, without being dismissed.

14 NOW, THEREFORE, IT IS HEREBY STIPULATED THAT:

15 Plaintiff Adeline Chan and the class of persons she represents who were subject to only one strip
16 search, prior to housing, without reasonable suspicion, shall be dismissed.
