1 THE PARTIES, BY AND THROUGH THEIR RESPECTIVE COUNSEL OF RECORD  
2 DO HEREBY STIPULATE AND AGREE AS FOLLOWS:

3 Whereas, the parties are continuing to meet and confer in good faith with respect to the  
4 issues concerning the attorneys' fees incurred by Plaintiffs on appeal;

5 Whereas, counsel for Defendants has requested additional time to respond to Plaintiffs'  
6 demand for attorneys' fees on appeal; and,

7 Whereas, the parties have previously stipulated to the transfer of the determination of  
8 Plaintiffs' fees on appeal to the District Court and for an extension of time of sixty days to file a  
9 motion for the appellate fees in the Ninth Circuit;

11 THE PARTIES DO HEREBY STIPULATE AND AGREE THAT Plaintiffs shall have  
12 up to an including September 14, 2010 to file a motion for an award of attorneys' fees on appeal  
13 in the District Court. This stipulation is not intended to alter the stipulation previously reached  
14 between the parties concerning the time for the filing of Plaintiffs' motion for an award of the  
15 attorneys fees incurred in the District Court.

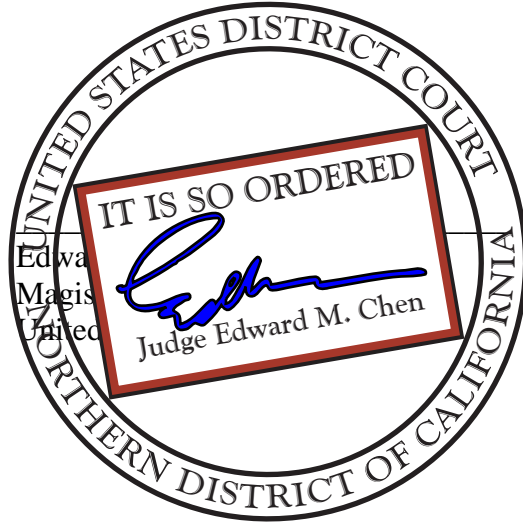
