11 Now pending before the Court are the motions of Becnel Law Firm, L.L.C., counsel for  
12 the above-named Plaintiffs, to withdraw as counsel of record for the above-named Plaintiffs.

13 After carefully considering the motions, the Court ORDERS PLAINTIFFS TO SHOW  
14 CAUSE as to why (1) counsel's motion to withdraw as counsel of record should not be granted;  
15 and (2) Plaintiffs' lawsuits should not be dismissed for a lack of prosecution. See Fed. R. Civ. P.  
16 41. If any Plaintiff wishes to contest the withdrawal of counsel and/or dismissal of Plaintiff's  
17 lawsuit for failure to prosecute, Plaintiff shall notify the Court **in writing** on or before  
18 August 20, 2010 of the reasons the withdrawal should not be granted or the case dismissed. If  
19 any Plaintiff will be proceeding without a lawyer, such Plaintiff must advise the Court of how the  
20 Court should contact Plaintiff.


21 Plaintiffs are warned that Plaintiffs' failure to communicate with the Court in writing as  
22 set forth above may result in dismissal of Plaintiffs' claims with prejudice.
