**STIPULATION AND [PROPOSED]
 ORDER RE BRIEFING SCHEDULE
 FOR PLAINTIFFS' JOINDER AND
 CONTEMPT MOTIONS**

 27 On December 24, 2008, Plaintiffs filed a "Motion to Join Governor Arnold
 28 Schwarzenegger as a Party Defendant" and a "Motion for Order Adjudging Governor Arnold

1 Schwarzenegger in Contempt for Failure to Appoint Statewide Dental Director” (collectively
2 “Motions”). The hearing date for Plaintiffs’ Motions was originally set for January 30, 2009. On
3 January 9, 2009, the Court approved the parties’ stipulation to continue the briefing schedule and
4 hearing date for Plaintiffs’ Motions by two weeks. On January 16, 2009, the Court *sua sponte*
5 continued the hearing date for Plaintiffs’ Motions to February 20, 2009 but did not alter the
6 briefing schedule stipulated to by the parties.

7 In light of the Court’s January 16, 2009 order, the parties agree to extend the briefing
8 schedule relating to Plaintiffs’ Motions by one week to correspond with the hearing date set by the
9 Court. Therefore, unless the parties further stipulate and/or the Court orders otherwise, the
10 briefing schedule for the Motions is as follows:

- 11 1) Defendants’ oppositions are due no later than Friday, January 30, 2009; and
- 12 2) Plaintiffs’ reply briefs are due no later than February 6, 2009.
