Many of you have already been involved with Burst and the internal tests we've conducted. To summarize, Burst offers several benefits over other solutions we've been evaluating:

the benefits of download and play (predictable amount of total bandwidth required to download entire media clip and guarenteed high content quality experience with no "streaming-jitter" irrespective of network latency) — essentially allowing us to deliver larger format, higher bandwidth video with a guaranteed quality level

the advantages of streaming (clip does not have to completely download before play begins, longer duration clips can play without need to download entire clip)

redundant architecture with no single point of failure (even if a server goes down, subscriber content experience during play is unaffected)

reduced complexity trial and deployment through ASP and centralized server deployment options (also reduced CAPX as architecture eliminates need to deploy distributed servers at RDC or Head Ends)

What to look for:

Note ability to play 300 and 600Kbps videos without skipping, which we've all experienced with traditional streaming – even with video encoded at 56Kbps over high latency networks.

If you want to look at the network statistics, right click on the video clip, select Properties, click the Advanced tab, select the Burst filter, then Properties. For a more advanced client (with very cool graphing and more statistics) contact Nick Huang or me.
