27 WHEREAS, Liberty's response to the complaint is due on January 25, 2006;



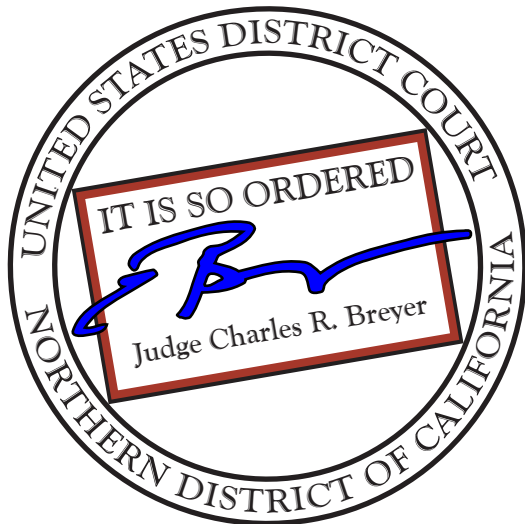
