**PLAINTIFFS' ADMINISTRATIVE
MOTION TO REMOVE INCORRECTLY
FILED DOCUMENT FROM DOCKET**

1 Plaintiffs respectfully request that an order be granted to remove document #93 from the
2 docket on the grounds that a portion of an exhibit to document #93 was incorrectly filed.
3 Document #93 contains information that is currently lodged with the court pursuant to Local Rule
4 79-5 and that the defendants claim should be filed under seal. This request is brought pursuant to
5 Civil Local Rule 7-11.

6 Today, May 1, 2006, at 12:02 p.m., plaintiffs inadvertently e-filed a document as part of an
7 exhibit to document #93 that contains information from documents currently lodged with the court
8 under seal. Plaintiffs intended to file this information under seal. The information is contained in a
9 notice for deposition pursuant to F.R.C.P. 30(b)(6) and references information from the documents
10 lodged pursuant to Local Rule 79-5. Due to a miscommunication with administrative staff, the
11 portion of the exhibit was e-filed and was not placed under seal. Plaintiffs immediately contacted
12 the ECF staff and the document was locked by 1:30 p.m. Plaintiffs have refilled the letter brief,
13 without the portion of the exhibit that should be under seal, as document #94.

14 Because a portion of the exhibit to document #93 was inadvertently filed as part of the ECF
15 system and should have, instead, been filed under seal pending the Court's determination of the
16 administrative motion under 79-5 set for May 17, 2006, plaintiffs respectfully request that
17 document #93 be immediately removed from the ECF system.
