**STIPULATION TO EXTEND DEADLINE
TO FILE PERSONAL TRAINER OPT-IN

23 On May 1, 2008 the Court entered an Order on Plaintiffs' Motion for Conditional
24 Certification and Facilitated Notice to Personal Trainers ("the Order") (Doc No. 193). The
25 Order directed the Notice Administrator to mail the Court approved notice and to process
26 Consent to Join Forms (Opt-in) forms submitted by Personal Trainers. The Order required
27 Opt-In forms to be filed with the Court within 10 days of the close of the Opt-in period. (§
28 7.) According to the notice the Personal Trainer Opt-in period closed on October 28, 2008.


1 The Parties, through counsel, having met and conferred with one another and the


