WHEREAS, Plaintiffs have found that many of the putative class members' addresses and telephone numbers are outdated, requiring Plaintiffs to spend additional time locating putative class members and preparing the class certification briefing so that Plaintiffs may use and/or respond to information from the putative class members (though Defendants do not concede that information generated from putative class members as a result of the Opt-Out Notice Letter process may be relevant, admissible or otherwise useable for class certification);
