- 2 • Plaintiffs submitted a proposed form of notice to the class. The parties have agreed
- 3 on this form of notice.
- 4 • Plaintiffs indicated that they have retained RG2 Claims Administration, LLP as
- 5 third-party notice administrator. Defendant has agreed to this selection.
- 6 • Plaintiffs submitted a proposed distribution list for the notice and described their

9 ORDERS the following:

- 10 1. The form of notice attached as Exhibit A to Plaintiffs' December 21, 2007 letter,

- 13 administrator.
- 14 3. The third-party notice administrator shall maintain a record of all class members
- 15 who opt out, and provide a report to the Court and parties of such within 30 days of
- 16 the conclusion of the opt-out period.
- 17 4. The Court approves of Plaintiffs' proposed distribution list, attached as Exhibit B to
- 18 Plaintiffs' December 21, 2007 letter, and distribution plan, including:
 - 19 a. Plaintiffs shall have until February 1, 2008 to have the case website,
 - 20 www.NFBtargetlawsuit.com, up and running.
 - 21 b. The third-party notice administrator shall insert in the notice a date certain
 - 22 for the opt-out deadline of 70 days from when notice is mailed/emailed.
