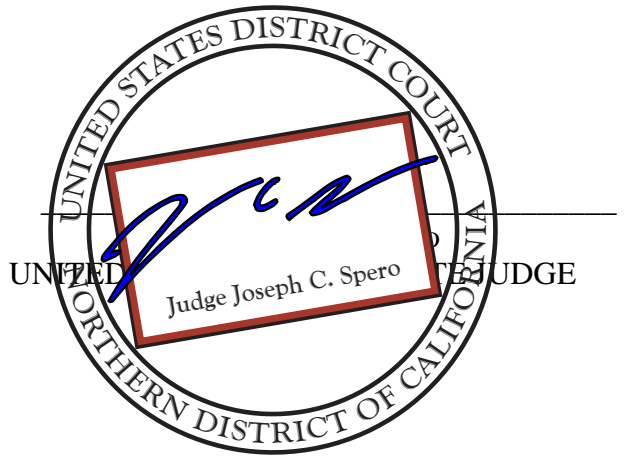
For good cause appearing, IT IS HEREBY ORDERED that:
