(Dkt. #36.) The Court 14 is now in receipt of Defendant's separate statement, which details its unsuccessful attempt to submit 15 a joint statement, despite repeated efforts to meet and confer with Plaintiff. The Court notes that 16 Plaintiff's failure to comply with the November 3 Order is part of a pattern in which Plaintiff has 17 failed to prosecute her case. (See, e.g., Dkt. ## 10, 12, 17.) Accordingly, the Court hereby 18 VACATES the December 11 Status Conference and ORDERS Plaintiff to show cause why this case 19 should not be dismissed for failure to prosecute and comply with this Court's orders. Plaintiff shall 20 file a declaration by December 17, 2008.
