**STIPULATION AND ORDER
 MODIFYING BRIEFING SCHEDULE
 AND HEARING DATE RE
 PLAINTIFF'S APPLICATIONS FOR
 A TEMPORARY RESTRAINING
 ORDER AND FOR EXPEDITED
 DISCOVERY**

24 WHEREAS on May 8, 2006, Plaintiff World Courier, Inc. ("World Courier") filed
 25 its Complaint for Damages commencing this action against defendants Doneen Barone, Jerra
 26 Langit, Sumitra Nadarajah, Marken Limited and Marken Worldwide Express (collectively,
 27 "Defendants");

1 WHEREAS on May 9, 2006, World Courier filed its Application for Temporary
2 Restraining Order and Issuance of Order to Show Cause Re: Issuance of Preliminary Injunction
3 (“Application for TRO”);

4 WHEREAS on May 9, 2006, World Courier also filed its Application for an Order
5 to Conduct Expedited Discovery (“Application for Expedited Discovery”);

6 WHEREAS on May 11, 2006, the Court issued an Order setting a briefing and
7 hearing schedule for the Application for TRO and the Application for Expedited Discovery, which
8 schedule requires Defendants to file their opposition memoranda and declarations to those
9 Applications by May 17, 2006, requires World Courier to file any reply memoranda and
10 declarations in connection with those Applications by May 23, 2006, and sets the hearing on those
11 Applications for May 31, 2006, at 10:00 a.m.;

12 WHEREAS World Courier and Defendants have been cooperating with each other
13 to attempt to narrow the issues in dispute between them with respect to the matters underlying the
14 Application for TRO and the Application for Expedited Discovery, but require additional time to
15 complete those efforts and to properly brief and prepare their respective submissions to the Court
16 in connection with the Application for TRO and the Application for Expedited Discovery;

17 NOW, THEREFORE, World Courier and Defendants hereby stipulate, by and
18 through their respective counsel, subject to the approval of the Court, that the briefing schedule
19 with respect to the Application for TRO and the Application for Expedited Discovery, and the
20 hearing date therefore, shall be modified as follows:

- 21 1. Defendants shall file their opposition memoranda and declarations to the
22 Application for TRO and the Application for Expedited Discovery by May 24,
23 2006;
- 24 2. World Courier shall file any reply memoranda and declarations to the Applications
25 for TRO and the Application for Expedited Discovery by May 30, 2006; and


