Good cause having been shown by the petitioner upon its petition filed in the above-entitled proceeding on 8/11, 2006, it is hereby:



**ORDERED** that a copy of this Order to Show Cause, together with a copy of the aforesaid petition, be served upon said respondents in accordance with Rule 4 of the Federal Rules of Civil Procedure at least thirty-five (35) days before the return date of this Order above specified; and it is

3 may file and serve a written response to the petition, supported by appropriate affidavit(s) or  
4 declaration(s) in conformance with 28 U.S.C. § 1746, as well as any motion he desires to make, that  
5 the petitioner may file and serve a written reply to such response, if any, within fourteen (14) days  
6 before the return date of this Order; that all motions and issues raised by the pleadings will be  
7 considered on the return date of this Order, and only those issues raised by motion or brought into  
8 controversy by the responsive pleadings and supported by affidavit(s) or declaration(s) will be  
9 considered at the return of this Order, and any uncontested allegation in the petition will be considered  
10 admitted.
