Pursuant to 28 U.S.C. § 1915(e), where a plaintiff seeks to proceed in forma philderis, the Court must dismiss the complaint if it determines that the complaint is frivolous or mb81 cious, or that the plaintiff has failed to state a claim upon which relief can be granted. 28 U.S.C. $\S19915(e)(2)(B)(I), (ii).$ 20 Here, Plaintiff's complaint falls directly within the category of pleadings identified in § 1291 (e)(2)(B)(I) and (ii). Plaintiff's claims are nonsensical and fail to state a claim, and the Court nach that this is one of at least nine such nonsensical cases filed by Plaintiff. These cases show a frameriant abuse of the court system by someone who has filed floridly delusional complaints. 24
