1 WHEREAS the parties have met and conferred regarding modifications to several dates set by  
2 the Court in its November 23, 2009 Case Management and Pretrial Order (Dkt. 805).

3 WHEREAS the proposed modifications are needed to accommodate the schedules of the counsel  
4 and to account for the delay in receipt by Plaintiffs of supplemental data provided by Defendant.

5 IT IS HEREBY STIPULATED by and between the parties through their counsel of record that  
6 the November 23, 2009 Case Management and Pretrial Order shall be modified as follows:

- 7 1. Filing deadline for the results of meet and confer process and briefs on disputed trial plan  
8 issues shall be moved from February 19 to February 26, 2010;
- 9 2. Filing deadline of Plaintiffs' expert witness Dr. Drogin's report shall be moved from  
10 February 15 to March 2, 2010;
- 11 3. Filing deadline of Defendant's expert witness Dr. Slottje's report shall be moved from March  
12 15 to April 2, 2010;
- 13 4. Second Case Management and Trial Planning Conference shall be moved from March 19 to  
14 April 2, 2010;
- 15 5. Deadline for completion of expert witness depositions shall be moved from April 1 to April  
16 16, 2010;
- 17 6. Filing deadline for the Proposed Final Pre-trial Order shall be moved from April 23 to April  
18 30, 2010;
- 19 7. Deadline for depositions of seven trial witnesses per side as identified in the proposed pretrial  
20 order shall be set for June 11, 2010;
- 21 8. Filing deadline for deposition designations related to the seven trial witnesses per side  
22 identified in the proposed pretrial order shall be set for June 30, 2010;
- 23 9. Filing deadline for counter designations and objections to the deposition designations related  
24 to the seven trial witnesses per side identified in proposed pretrial order shall be set for July  
25 9, 2010; and
- 26 10. The mediation scheduled for April 7, 2010, before Hon. Edward Infante (Ret.) (JAMS) shall  
27 be moved to April 22, 2010.

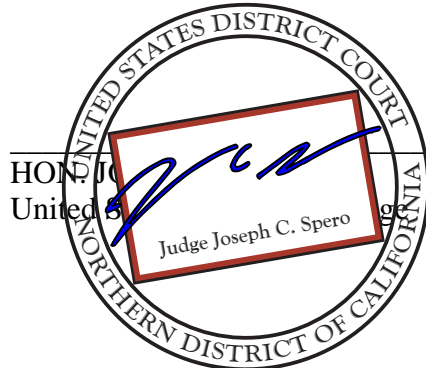
