
**STIPULATION AND ORDER OF

24 hereby stipulate that all claims of plaintiff Gloria Natividad, only, against defendants G.D.
25 SEARLE & CO., PHARMACIA CORPORATION; MONSANTO COMPANY and PFIZER, and
26 all other named defendants be dismissed in their entirety with prejudice, each party to bear its own
27 costs. Plaintiff Gloria Natividad's claim was filed in a consolidated, multi-plaintiff complaint

1 does not affect any claim brought by the remaining plaintiffs.


