22 **RECITALS**

23 The parties participated in mediation with the Honorable Edward Infante (Ret.) on
 24 November 12, 2009. The parties were successful in reaching a settlement agreement resolving
 25 this matter.

26 The settlement agreement is contingent on three things: (1) Approval by the Oakland
 27 City Council; (2) The signing of settlement agreements and releases by at least 92% of
 28 Plaintiffs; and (3) Approval by the Court. The earliest the Oakland City Council can consider

1 this matter in Executive Session is December 8, 2009, and the earliest it can formally act on the
2 settlement agreement is January 5, 2010.


3 Plaintiffs will begin their approval process immediately after the City Council's
4 Executive Session on December 8, 2009. Plaintiffs' counsel believes that it will require sixty
5 (60) days to communicate with and obtain approval from the 562 Plaintiffs.

7 **STIPULATIONS**

8 The parties stipulate that, with the consent of the Court, the trial date in this matter
9 should be continued from January 25, 2010, to March 22, 2010, and that the date for the pretrial
10 conference should be continued from January 12, 2010, to ^{as set by the court.} ~~March 22, 2010.~~




