On March 31, 2010, the court granted plaintiffs' motion for summary judgment of liability on their claim that defendants, in their official capacities, violated the Foreign Intelligence Surveillance Act ("FISA"), 50 USC §§ 1801 et seq, but dismissed plaintiffs' claims against FBI Director Mueller in his personal capacity. Doc #721/115. On December 21, 2010, the court granted the motion of plaintiffs Wendell Belew and Asim Ghafoor for liquidated damages against defendants in their official capacities, denied liquidated damages or any other recovery to plaintiff Al Haramain Islamic Foundation, Inc, granted the motion of plaintiffs Belew and Ghafoor for attorney fees and expenses, denied all other relief requested by plaintiffs, granted plaintiffs' request to dismiss without prejudice plaintiffs' Second, Third, Fourth, Fifth, and Sixth claims for relief and directed the clerk to enter judgment.

Now, therefore, IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

- 1. Plaintiffs Ghafoor and Belew shall each recover a total sum of \$20,400 in liquidated damages from defendants in their official capacities Barack H Obama, President of the United States; Keith B Alexander, the Director of the National Security Agency; Adam J Szubin, the Director of the Office of Foreign Assets Control; and Robert S Mueller III, the Director of the Federal Bureau of Investigation; and
- Plaintiffs Ghafoor and Belew and their counsel shall recover a total sum of \$2,515,387.09 in attorney

fees and \$22,012.36 in expenses from defendants in their official capacities Barack H Obama, President of the United States; Keith B Alexander, the Director of the National Security Agency; Adam J Szubin, the Director of the Office of Foreign Assets Control; and Robert S Mueller III, the Director of the Federal Bureau of Investigation.
