[PROPOSED] ORDER RE-SETTING DEADLINES

1 Having considered the Miscellaneous Administrative Motion (the "Motion") of Plaintiffs
2 Bernard Paul Parrish, Herbert Anthony Adderley, and Walter Roberts III (collectively,
3 "Plaintiffs"), the response of Defendants National Football League Players Association
4 ("NFLPA") and National Football League Players Incorporated d/b/a Players Inc ("Players Inc"),
5 all other papers filed herein, and the records of the case, the Court hereby orders as follows:

6 IT IS HEREBY ORDERED that Plaintiffs' Motion is GRANTED.

7 IT IS FURTHER ORDERED that the following dates and deadlines are to be adopted
8 going forward (independent of the deadline for Plaintiffs' Motion for Class Certification, as
9 explained below):

10 <u>May 23, 2008</u> :	Non-expert discovery cut-off
11 <u>May 23, 2008</u> :	Last day to file expert reports
12 <u>June 13, 2008</u> :	Last day to submit expert "opposition reports"
13 <u>June 27, 2008</u> :	Last day to file expert reply reports
14 <u>July 9, 2008</u> :	Close of expert discovery
15 <u>July 11, 2008</u> :	Last day to file dispositive motions
16 <u>September 8, 2008 @ 2:00 pm</u> :	Final Pretrial Conference
17 <u>September 22, 2008 @ 7:30 am</u> :	Jury trial commences

18 IT IS HEREBY FURTHER ORDERED that the new deadline for Plaintiffs' Motion for
19 Class Certification is February 7, 2008, with such Motion being heard on a 49-day track.

20 IT IS HEREBY FURTHER ORDERED that, except as expressly stated herein, all other
21 deadlines and information included in the Court's June 14, 2007 Scheduling Order remain
22 unchanged.
