
## Blue Skies, Blue Waters Await Convention Attendees

Azure skies, miles of sand beaches, a daily average temperature of 82, rich rainforests and majestic mountains will greet attendees at this year's NFLPA Retired Players Convention, which will be held in Puerto Rico, Wednesday May 28 through Sunday June 1, 2008. The event will be held at The Ritz-Carlton San Juan Hotel, Spa and Casino.

"Attending the Convention provides the opportunity for your voice to be heard as a former player and member of the NFLPA," said NFLPA Retired Players Director **Andre Collins** "We've got an exciting agenda of speakers and educational seminars and plenty of relaxing and entertaining activities in between."

The convention's keynote speaker will be former quarterback and 12-year ESPN analyst **Sean Salisbury**. Attendees will also hear from NFLPA Executive Director **Gene Upshaw** on the "State of the Union," and NFLPA

Benefits Director **Miki Yaras-Davis** will give an update on the recent disability and benefit improvements. An overview of the newly formed Alliance, comprised of the NFL, NFLPA, Pro Football Hall of Fame and NFL Alumni Association, will also be given.

Steering Committee President Jean Fugett will give a report on the active Player Representative's Meeting he will attend this month. (Fugett is serving his final year as president, however he is still eligible to be re-elected for one

more three-year term as a Steering Committee member.)

On Wednesday, May 28, the NFLPA will hold its third Exit Symposium. This event is geared toward recently retired players and will help guide them as they transition into life after football. Attendees will hear from professionals on post-career financial information and career transition tools including resume building, interview skills and career counseling. The convention is also the site of the 4th Annual Career Opportunity Expo on Friday, May 30. The Expo provides retired players with new career opportunities and business networking.

The annual golf tournament will be held Thursday morning at one of the island's premier courses. Convention parties will include the opening "Welcome to San Juan" reception on Thursday, which will feature local island flavor and entertainment, and the farewell reception on Saturday evening,

## NFL And NFL Players Association Expand Disability Benefits Program For Retired Players

The NFL Alliance, with representatives from the NFL, NFL Players Association, Pro Football Hall of Fame and NFL Alumni Association, announced further improvements to the NFL disability benefits program as part of the Alliance's commitment to address the medical and disability needs of retired NFL players.

Ten former players, including Hall of Fame members Harry Carson, Willie Lanier and Steve Largent, plus Steering Committee President Jean Fugett, Retired Players Director Andre Collins, NFLPA President Troy Vincent and John Wooten, were in attendance. Other attendees included NFL Commissioner Roger Goodell, NFL Players Association Executive Director Gene Upshaw, NFL Alumni President Frank Krauser and Pro Football Hall of Fame President and Executive Director Steve Perry.

At the meeting held on February 28, the NFL and NFLPA announced agreements that would both significantly expand eligibility for disability benefits and increase the amount of the benefit paid to certain recipients. The particular changes announced today are:

- A doubling of the minimum benefit post-career, nonfootball "total and permanent" disability from \$20,000 to \$40,000 per year for retired players who become disabled unrelated to football. Players would otherwise receive the full amount of their pension, if greater.
- Players who took their NFL pension early, and are therefore ineligible to apply for and receive disability benefits, will be offered a new one-time opportunity to apply for total and permanent disability benefits. These players may establish their disability through either a medical examination or by a total and permanent disability determination from Social Security. The opportunity to apply for benefits will begin on April 1, 2008. Applications will be accepted through July 31, 2008.
- Players who have received a total and permanent disability determination from Social Security will not need to separately establish disability under the NFL plan. Players who were denied benefits under the NFL plan but have sub-

sequently been found disabled by Social Security may have their NFL cases reconsidered. The other good news for retired NFL players is that NFL disability awards are not offset by the amount of any award paid by Social Security.

The time within which to apply for line of duty disability benefits has been lengthened from the current 48month period to 48 months or the player's actual number of credited seasons. For example, a 10-year veteran would have 10, rather than, as previously, four years, to apply for this benefit.

"These improvements are part of the longstanding commitment of current players and the Players Association to the retired players who came before us," said Gene Upshaw.

"We are proud to improve upon the most extensive benefits package in professional sports by going well beyond what has been available through our Collective Bargaining Agreement," said Harold Henderson, NFL executive vice president of labor relations. "These voluntary improvements are consistent with our commitment to address post-career issues and improve the benefits of retired players. No other industry reaches back like this to take care of former employees."

The enhancements in disability benefits announced at the meeting are in addition to a series of other improvements announced in December that are designed to reduce red tape, improve the level of service provided to applicants and their families, ensure consistent and high-quality medical reviews, and provide for more prompt decisions on applications for disability benefits under the player pension plan.

The Alliance will continue to meet to discuss concerns of retired players and monitor the progress and results of the new programs announced over the past several months.





which will transport attendees to the site of the 2009 convention.

Ladies' events will include the popular "Get Acquainted Breakfast" followed by interactive activities and shuttles to Old San Juan for shopping and sightseeing. There will also be an educational seminar for the ladies on Friday morning.

Collins noted that traveling to Puerto Rico is as easy as, say, traveling to Atlanta, where the convention was held last year. "Puerto Rico is a United States Commonwealth," he said, "so it uses the same currency, the same phone system, the same postal rates, the same electrical standards, even the same language (English and Spanish are both officially spoken)." U.S. citizens do not need passports or visas to travel to Puerto Rico from the States.

A special room rate of \$169/night plus tax has been negotiated for the convention group. The Ritz-Carlton is located on beachfront property in Isla Verde, just five minutes from Luis Munoz Marin International Airport and 15 minutes from historic Old San Juan. The resort has five restaurants, including BLT Steak and Il Mulino New York, a 12,000 square-foot spa, a fitness center and tennis courts. A 24-hour casino features traditional games such as Blackjack, Roulette, Baccarat

and Craps as well as state of the art slot machines.


example of musical expression soon to be developed. I travel the country, which is important because the world is my color-filled backdrop, my physical aid."
