1           Having considered Plaintiffs’ petition for a preliminary and final award of attorneys’ fees,  
2 reimbursement of their costs and expenses which are substantial, request that the sole class  
3 representative, Herbert Adderley, be awarded an incentive fee for his generous participation on  
4 behalf of the entire GLA Class, and a determination of the form of class notice on the above (the  
5 “Petition”), any Opposition to the Petition, and all other papers filed herein, the records of the  
6 case, and the oral argument on the Petition, if any, the Court hereby orders as follows:

7           IT IS HEREBY ORDERED that the Petition is GRANTED

8           IT IS FURTHER ORDERED that the requested attorneys’ fees , costs and other expenses  
9 are fair and reasonable under the applicable legal standards and in light of the risks incurred, the  
10 result achieved, and the effort expended. As well, it is appropriate to award Herbert Adderley an  
11 incentive award.
