1 Having considered Class Counsels' Renewed Application for fees, expenses and an
2 incentive payment for Class Representative Herbert Adderley ("Motion"), and all other papers
3 filed herein, the records of the case, and the oral argument on the Motion, if any, the Court hereby
4 orders as follows:

5 IT IS HEREBY ORDERED that the Motion is GRANTED.

6 IT IS FURTHER ORDERED that Plaintiffs' Counsel shall be awarded thirty percent
7 (30%) of the \$26,250,000 settlement amount (minus expenses) for legal services performed on
8 behalf of the Class, or \$7,369,648.90.

9 IT IS FURTHER ORDERED that Plaintiffs' Counsel shall receive the amount of their
10 expenses, which total \$1,684,503.67.

11 IT IS FURTHER ORDERED that Class Representative Herbert Adderley be awarded an
12 incentive amount in the amount of \$60,000.00.
