1 I, Herbert Anthony Adderley, declare as follows:

2 1. I am a party to this lawsuit. I am submitting this Declaration in support of Class
3 Counsels' motion for final approval of the settlement agreement. The following declaration is
4 based upon my personal knowledge. If called as a witness I could and would competently testify
5 to the facts set forth herein.

6 2. I am a retired professional football player who played for more than 10 years in the
7 National Football League ("NFL") for the Green Bay Packers and the Dallas Cowboys. I was
8 elected to be a member of the professional football Hall of Fame in 1980.

9 3. I have been a party to this case since it was first filed in February 2007. I was
10 deemed to be an adequate class representative on April 29, 2009 and served as the Class
11 Representative for the GLA Class from the moment the class was certified.

12 4. I have previously submitted several declarations in this case. On November 26,
13 2008, I submitted a declaration explaining the amount and type of work I did in my role as Class
14 Representative. A copy of my November 26, 2008 Declaration is attached hereto as Exhibit A.

15 5. I have reviewed the settlement agreement and am familiar with its terms. I have
16 also spoken with Class Counsel about it. In my opinion, the settlement agreement represents a
17 tremendous accomplishment on behalf of the GLA Class, especially since the Class Members will
18 be receiving \$26,250,000 (which is a just a little less than the \$28,100,000 awarded by the jury)
19 without the risk and uncertainty of continued litigation. I believe that the settlement agreement is
20 in the best interest of the GLA Class.

21 I declare under penalty of perjury under the laws of the United States that the foregoing is
22 true and correct and that this declaration was executed on October 15, 2009.
