**[PROPOSED] ORDER GRANTING CLASS
 COUNSELS' MOTION FOR APPROVAL
 RE SECOND DISTRIBUTION FROM THE
 SETTLEMENT FUND**

1 Class Counsel has moved the court to approve the second payment to those Class
2 Members who submitted completed Claim Forms in the manner and method described in Class
3 Counsels' Motion For Approval Re Second Distribution from the Settlement Fund (the
4 "Motion").

5 Having considered Class Counsels' Motion ("Motion"), and all other papers filed herein,
6 the records of the case, and the oral argument on the Motion, if any, the Court hereby orders as
7 follows:

8 IT IS HEREBY ORDERED that the Motion is GRANTED.

9 IT IS FURTHER ORDERED that

10 (1) the Claims Administrator shall distribute to those 1,792 Class Members who timely
11 submitted complete Claim Forms a second payment from the Settlement Fund in the amounts
12 identified on the payment matrix attached as Exhibit F to the Declaration of Lewis T. LeClair In
13 Support of the Motion;

14 (2) the Claims Administrator shall distribute to those seven Class Members who
15 submitted timely but deficient Claim Forms a total of \$38,098.44 from the Settlement Fund;

16 (3) Class Counsel shall pay the Class Administrator \$65,597.35 from the Settlement Fund
17 in connection with its June 24, 2010 invoice;

18 (4) Class Counsel shall pay \$7,139.64 from the Settlement Fund to reimburse McKool
19 Smith;

20 (5) Class Counsel shall pay \$580.00 from the Settlement Fund to LECG for confirming
21 the accuracy of the payment matrix; and

22 (6) Class Counsel shall not distribute any funds to those Class Members who either did
23 not submit a Claim Form that was postmarked on or before June 1, 2010, or for whom the Class
24 Administrator does not have any record of having received a Claim Form on or before June 1,
25 2010.

26 IT IS SO ORDERED.
