1 LEWIS T. LeCLAIR declares:

2 I am an attorney and a member of the bar of the State of California. I am a shareholder at
3 the law firm of McKool Smith, P.C. in Dallas, and served as lead counsel for my firm and co-
4 counsel for plaintiff Herb Adderley and the certified class in this action. I am submitting this
5 declaration in support in support of Class Counsels' and Defendants' Response to July 12, 2010
6 Order.

8 1. On November 11, 2008, the Class Members received a jury verdict in the amount
9 of \$28.1 million. The verdict received a significant amount of media attention.

10 2. On July 14, 2010, following the Court's most recent Order, I met and conferred
11 with one of the counsel for Defendants pursuant to the Court's July 12, 2010 Order. During the
12 conversation, I asked whether Defendants could provide Class Counsel with the social security
13 number for each Class Member who has yet to receive his share of the Settlement Fund. The
14 purpose of the information would be to allow the Claims Administrator to run additional
15 searches to locate each Class Member's current address. Defendants' counsel agreed to provide
16 the Claims Administrator through Class Counsel with the information for such purpose.
