**[PROPOSED] ORDER GRANTING CLASS
 COUNSELS' MOTION FOR FINAL
 ORDER APPROVING PAYMENTS TO
 THE GLA CLASS**

1 The Court has received and reviewed Class Counsels' status update, and report concerning
2 efforts to find additional class members and transmission of third Claim Forms to Class Members
3 for whom they recently obtained updated address information (the "Report"). The Court also has
4 received and reviewed Class Counsels' motion for final approval with respect to payments to the
5 GLA Class, including determination of all remaining issues (the "Motion").

6 Having considered Class Counsels' Motion and Report, and all other papers filed herein,
7 the records of the case, and the oral argument on the Motion, if any, the Court hereby orders as
8 follows:

9 IT IS HEREBY ORDERED that the Motion is GRANTED.

10 IT IS FURTHER ORDERED that

11 (1) Class Counsel is [authorized / not authorized] to pay from the Settlement Fund those
12 six Class Members mentioned in the Motion and discussed on **Exhibit 1** to the Katz Declaration
13 and the two players whose Claim Forms were received after the deadline.

14 (2) Class Counsel is authorized to send final payments to each of the Class Members who
15 is entitled to a share of the Settlement Fund in the amount to which each Class member is entitled.

16 (3) Class Counsel is authorized to pay the Garden City Group (the "Claims
17 Administrator") all outstanding fees through completion of the project in the amount of
18 \$119,505.21.

19 (4) Class Counsel is authorized to pay their damages expert, LECG, in the amount of
20 \$1,015 for LECG's work confirming the accuracy of the numbers in the spreadsheets showing
21 payments to Class Members.

22 (5) Class Counsel is authorized to reimburse McKool Smith, P.C. in the amount of
23 \$7,139.64 for funds that McKool inadvertently paid to the Claims Administrator that should have
24 come out of the Settlement Fund.

25 IT IS SO ORDERED.
