ORACLE'S RESPONSE TO COURT'S ORDER DATED DECEMBER 14, 2010

1 In response to the Court's Order and request, dated December 14, 2010 (Dkt. 1012),
2 Oracle hereby confirms that *all* of the relief that Oracle seeks to close the case is set forth within
3 the proposed form of judgment submitted herewith. This proposed form of judgment differs
4 from the proposed form of judgment, dated December 10, 2010 (Dkt. 1009), only in making
5 explicit that "judgment is entered" against all Defendants on Oracle's claim for copyright
6 infringement. To the extent Defendants, in their submission one week from now, raise any
7 issues not addressed in Oracle's Memorandum submitted on December 10, 2010 (Dkt. 1009),
8 Oracle respectfully requests the opportunity to have at least two business days to address those
9 issues.
