12 those instances, the designated witness shall be deemed to be the entity on whose behalf the
13 individual provided the deposition testimony.

14 This list is limited to the claims and defenses currently available in this case based on the
15 parties' stipulations and the Court's prior orders. Defendants' list does not include witnesses
16 whose testimony would be offered solely in support of the admissibility of certain documents.
17 See Fed. R. Evid. 104(a). Moreover, consistent with this Court's orders, the attached list does not
18 necessarily include all those witnesses whom Defendants may call at trial solely for impeachment
19 or rebuttal.
