Any customer at risk is tracked very closely at the regional manager level. Each regional manager has a weekly review of any accounts at risk with the support sales rep on those accounts. As you are aware, my team has the a large majority of JDE/PSFT accounts, but there are also approximately 2,000 renewals in Romania and a couple thousand renewals spread across the Oracle team as well. There is not a "system" report for reporting all renewals at risk at the current time and therefore, there is not a consolidated report available. Each team is managing this within their teams.
