1 Pending before this Court is Plaintiffs' Administrative Motion to Permit Plaintiffs to File
2 Under Seal Defendants' Information Supporting Plaintiffs' *Daubert* Motions, Oppositions to
3 Defendants' Motions *in Limine*, and 17 U.S.C. § 410(c) Motion (D.I. 784, and hereafter "Motion
4 to Seal"). Through the Motion to Seal and supporting documentation, Plaintiffs Oracle USA,
5 Inc., Oracle International Corporation, and Siebel Systems, Inc. (collectively, "Plaintiffs"),
