1	Pending before this Court is the Administrative Motion to Seal Plaintiffs'		
2	Documents in Support of Defendants' Opposition to Plaintiffs' Motion No. 1 to Exclude Expert		
3	Testimony of Stephen K. Clarke ("Defendants' Motion to Seal") (Dkt. No. 857) filed by SAP		
4	AG, SAP America, Inc., and TomorrowNow, Inc. (collectively, "Defendants"). Through		
5	Defendants' Motion to Seal and Plaintiffs' Response in Support of Defendants' Motion to Seal		
6	("Plaintiffs' Response") (Dkt. No. 870), the Parties request an Order sealing portions of the		
7	Declaration of Stephen K. Clarke in Support of Defendants' Opposition to Plaintiffs' Motion No.		
8	1 to Exclude Expert Testimony of Stephen K. Clarke ("Clarke Declaration") at paragraph 32, an		
9	figures 1 and 4.		
10	Federal Rule of Civil Procedure 26(c) provides broad discretion for a trial court to		
11	permit sealing of court documents for, inter alia, the protection of "a trade secret or other		
12	confidential research, development, or commercial information." Fed. R. Civ. P. 26(c). In		
13	particular, when the request for sealing concerns discovery documents attached to a		
14	nondispositive motion, a showing of good cause to seal the documents is sufficient to justify		
15	protection under Rule 26(c). See Navarro v. Eskanos & Adler, Case No. C-06 02231		
16	WHA(EDL), 2007 U.S. Dist. LEXIS 24864, at *7 (March 22, 2007) (citing Kamakana v.		
17	Honolulu, 447 F.3d 1172, 1179 (9th Cir. 2006)).		
18	In compliance with this Court's Standing Order Involving Sealed or Confidential		
19	Documents, Rule 26(c) and Civil Local Rule 79-5, Plaintiffs filed the Declaration of Jennifer		
20	Gloss (the "Gloss Declaration") in support of Defendants' Motion to Seal on September 15,		
21	2010. Through the Gloss Declaration and Plaintiffs' Response, Plaintiffs provide evidence of		
22	good cause sufficient for this Court to permit filing portions of the requested document under		
23	seal. The Gloss Declaration establishes both that Oracle has considered and treated the		
24	information contained in the document as confidential, commercially sensitive and proprietary,		
25	and that public disclosure of such information would create a risk of significant competitive		
26	injury and particularized harm and prejudice to Oracle. The Gloss Declaration also establishes		
27	that the request for sealing has been narrowly tailored.
