1 WHEREAS Plaintiffs' Motion to Amend is set for hearing on May 3, 2010.

2 WHEREAS Defendant's Opposition to Plaintiffs' Motion to Amend is due
3 to be filed on April 12, 2010 pursuant to Local Rule 7-3(a).

4 WHEREAS Plaintiffs' Reply is due April 19, 2010 pursuant to Local Rule
5 7-3(c).

6 WHEREAS Counsel for the Defendant requests an extension of one court
7 day to April 13, 2010 to file the Opposition as a result of defense counsel's
