 PLAINTIFFS' MOTION FOR
 ATTORNEYS' FEES AND [PROPOSED]
 ORDER**

1 Plaintiff Center for Biological Diversity (the "Center") and Federal Defendants, Environmental
2 Protection Agency, et al. jointly request leave for an extension of sixty days for Plaintiff to file a motion
3 for an award of litigation costs and attorneys' fees.

4 On May 17, 2010, this Court issued an Order in this case granting Plaintiff and Defendants' joint
5 motion for entry of stipulated injunction. That Order allowed for sixty days in which to resolve fees and
6 costs.

7 On July 8, 2010, the Court approved the Parties' First Request for an Extension of Time for
8 Plaintiff to File its Attorneys' Fees Motion, and set a new deadline of September 14, 2010.

9 The Parties continue to discuss settlement and believe an additional sixty days for discussions
10 may preclude the need to file a fee motion, and therefore respectfully request that the Court grant an
11 additional sixty days until November 15, 2010.


