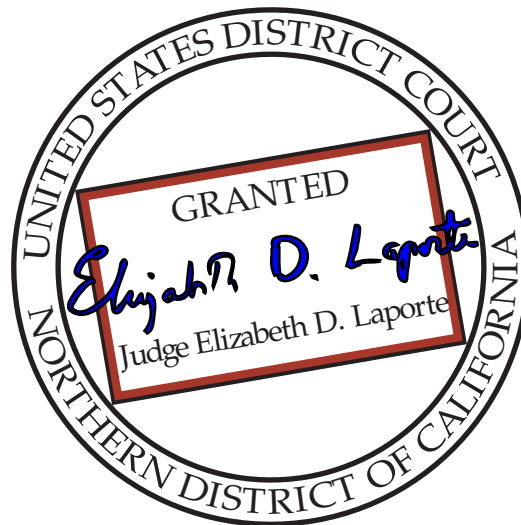
1 TO THE COURT AND ALL PARTIES HEREIN:
