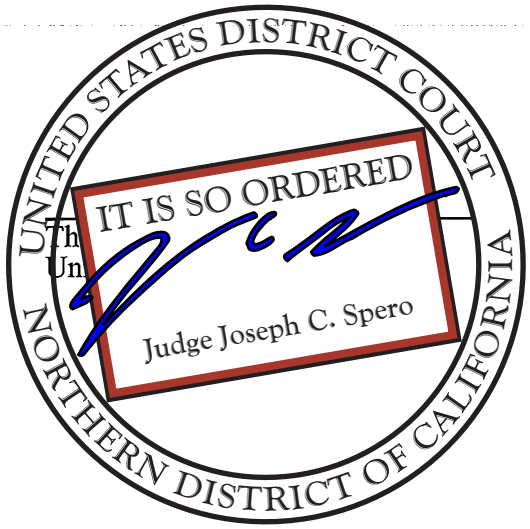
15 **[PROPOSED] ORDER**
