36 The parties, by and through their attorneys of record, hereby stipulate and request that the
 37 Case Management conference currently scheduled for October 10, 2008, be re-scheduled for
 38 November 14, 2008. In support thereof, the parties would show the court the following:

- 39 1. This case is currently set for a Case Management Conference ("CMC") on October
 40 10, 2008. The CMC was set for this date in order that the parties might participate in a settlement
 41 conference prior to the CMC. The settlement conference was held on September 29, 2008 and the

1 parties reached a settlement, subject only to the approval of the San Mateo board of Supervisors.
2 The settlement was read into the record by Magistrate Chen, with the parties and their respective
3 counsel putting their agreement thereto on the record. The Board of Supervisors met on October 7,
4 2008 and approved the settlement.

5 2. The parties respectfully request that the CMC be moved to November 14, 2008 in
6 order that the parties may carry out the terms of the settlement and request for dismissal.

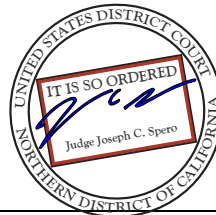
