 22 Since the last communication with this Court, the pending criminal action in Lake County  
 23 was reset to commence on October 27, 2009. There is only one subject area in which plaintiff  
 24 believes that discovery could go forward if the criminal case is not completed. (Monell  
 25 discovery). The defense disagrees. Given that the criminal case will be completed shortly,

1 which will therefore terminate all bases for the stay in this action, and that there has been no  
2 change in the case since the last Case Management Conference, the parties believe that it is in the  
3 best interest of all parties and a better use of court time to postpone the existing Case  
4 Management Conference Date.

5 It is, therefore, stipulated by and between all the parties to this action by and through their  
6 respective attorneys of record, that the Case Management Conference scheduled for October 5,  
7 2009 be rescheduled to a date after November 23, 2009.

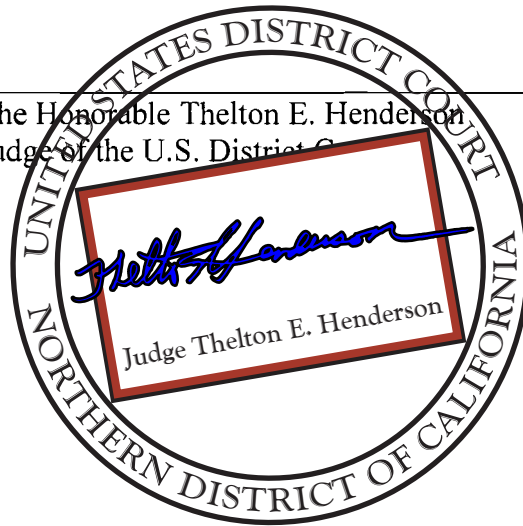
1 **ORDER**
