3 WHEREAS, counsel for Plaintiffs is unavailable on that date; and


4 WHEREAS, defendant's counsel has been informed of Mr. Guta's unavailability and have

7 December 18, 2009, at 8:30 a.m.;


8 IT IS HEREBY AGREED by and between plaintiffs Luis Contreras, Saul Avila, Carlos
